The payer ID number listed on the identification cards from UnitedHealthcare (UHC) incorrectly instructs you to file claims to UHC instead of to The Alliance. The error also appears on the online eligibility tool.

To avoid unnecessary claims denials and processing delays, regardless of what UHC advises, please forward claims to The Alliance whenever our address is referenced on the back of the ID card presented by the patient.

Claims sent to the UHC payer ID will be denied by UHC and indicate that it needs to be filed to The Alliance for repricing. If this occurs, please update the patient file with the correct Alliance payer ID numbers (below) and refile to The Alliance. We will then reprice the claim and send it to UHC for reprocessing.
