It has come to our attention that the United Healthcare (UHC) online eligibility tool and payer # on ID card incorrectly instructs you to file claims to UHC. UHC is not able to customize this site for Alliance enrolled employees so, regardless of what UHC advises, continue to file claims to The Alliance.
